A. In order to secure the a certain loan made by Mortgagee to Mortgagor, the Mortgagor executed and delivered to Mortgagee (i) a certain Mortgage dated May 27, 2005 from Mortgagor to Mortgagee, recorded with the Cook County Recorder of Deeds as document No. 0415332006 (the "Mortgage") granting Mortgagee a mortgage on real property commonly known as 512 West Barry Street, Chicago, Hirois and legally described on the attached Exhibit A (the "Premises") and (ii) a certain Assignment of Rents dated May 27, 2005 from Mortgagor to Mortgagee, recorded with the Cook County Recorder of Deeds as document No. 0415332006 (the "Assignment of Rents").

B. Mortgagor has converted the Premises to a form of ownership commonly referred to as "condominiums" and desires to soll one of the condominium units which comprise a portion of the Premises and Mortgagee desires to release any interest it has in such unit (but not its interest in the remainder of the Premises).

NOW, THEREFORE, Mortgagee hereby releases any interest it may have in the condominium unit which comprises a portion of Premises which is legally described on Exhibit B, including any interest evidenced by either (i) the Mortgage or (ii) the Assignment of Rents. The lien of Mortgagee described in the Mortgage and Assignment of Rents shall remain on any portion of the Premises not previously released or specifically released pursuant hereto.
