This covenant is made to induce the City of Chicago to furnish sewer and water service to the premises set forth in the attached Exhibit A.

All terms, provisions, stipulations, covenants and conditions to be performed by Strong Development, LLC are undertaken by it solely as owner, as aforesaid, and not individually, and all statements herein made are made on information and belief and are to be construed accordingly; and no personal liability shall be asserted or be enforceable against Strong Development, LLC, its members or agents by reason of any of the terms, provisions, stipulations, covenants and/or statements contained in this instrument.
