EXHIBIT A <u>LEGAL DESCRIPTION OF RELEASED COLLATERAL</u>

PARCEL 1:

All of Lot 5 and that part of Lot 3 in Brookmere Subdivision, being a resubdivision of part of Matteson Commons Subdivision in the East Half of Section 16, Township 35 North, Range 13 East of the Third Principal Meridian, in the Village of Matteson, Cook County, Illinois, according to the plat thereof recorded August 28, 2003 as Document No. 0324519012, described as follows:
