EXHIBIT "A" TO SPECIAL WARRANTY DEED

PARCEL 1:

UNIT NO. 914-2-SOUTH in the **AGATITE HARBOR CONDOMINIUM** as delineated on a survey of the following described property:

Lots 56 and 57 in A.T. Galt's Sheridan Road Subdivision in the East 1/2 of the Northeast 1/4 of Section 17. To vnship 40 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

Which survey is attached to the Declaration of Condominium recorded as Document No. 0503119041 together with an undivided percentage interest in the common elements.

PARCEL 2:
