The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as:

(the "Condominium Project"). If the owner association or other entity which acts for the Condominium Project (the "Owners Association") holds litle to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses,
