SECOND AMENDMENT

TO THE DECLARATION

WHEREAS, the condominium unit owners of The Oaks of Oak Lawn Condominiums Phase II duly amend the Declaration as set forth herein at an annual meeting of the unit owners of The Oaks of Oak Lawn Condominiums Phase II held at the Property on November 15, 2004;

NOW THEREFORE the Declaration is hereby amended, effective as of the date of this instrument as follows:

- 1. No condominium unit owner may park, store, or otherwise keep a commercial vehicle (of any kind), a boat, a camper, or a trailer within the building's garage (parking area), within the attached parking lot, on any of the outside common areas, or property. Further, a condominium unit owner must assure that all relatives, guests, agents, and/or other individuals comply with this parking prohibition. However, contractors, delivery people, and/or other service providers are allowed to park or the premises only for the length of time necessary to perform their duties, with the consent, under the direct supervision, and with all liabilities going to the condominium unit owner.
- 2. The condominium unit owners, at all times, wish to be in compliance with all federal, state, county, and municipal laws, codes, and regulations. If any provision, word, or wording within the Declaration, Rules and Regulations, or any condominium document fails to comply, that provision, word or wording shall be amended or stricken, without a vote by the condominium unit owners, so compliance with the 12.w3, codes, and regulations is maintained.
 - 3. Except as herein amended, the Declaration is ratified and confirmed.
