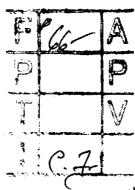

# FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM FOR THE 940-44 WEST COLLEGE PARKWAY CONDOMINIUMS

THIS FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM FOR THE 940-44 WEST COLLEGE PARKWAY CONDOMINIUMS (this "Amendment") is made and entered into as of the 11th day of May, 2004 by SOUTH CAMPUS DEVELOPMENT TEAM, L.L.C., an Illinois limited liability company (hereinafter referred to as the "Declarant").

WHEREAS, Declarant hereby intends to record this Amendment for the sole purpose of correcting said typographical error to reflect the correct legal description of the Parcel.

NOW THEREFORE, the Declarant hereby declares as follows:

- 1. The correct legal description of the Parcel is set forth on <u>Attachment A</u> attached hereto. All references in the Declaration to <u>Exhibit A</u> shall also be deemed to refer to the legal description attached hereto as <u>Attachment A</u>.
- 2. The Plat attached to the Declaration as <u>Exhibit D</u> is hereby an ended by deleting Sheet 1 of 2 thereto in its entirety and substituting in lieu thereof a substitute Spect 1 of 2 which is attached hereto as <u>Attachment B</u> and which depicts the correct legal description of the Parcel. All references in the Declaration to the Plat shall be deemed to refer to the Plat as amended hereby.
- 3. All references in the Declaration to the Declaration shall mean the Declaration as amended hereby. All references in the Declaration to the Condominium Instruments shall hereby be deemed to include this Amendment. Except as otherwise expressly amended by this Amendment, the Declaration shall remain in full force and effect.

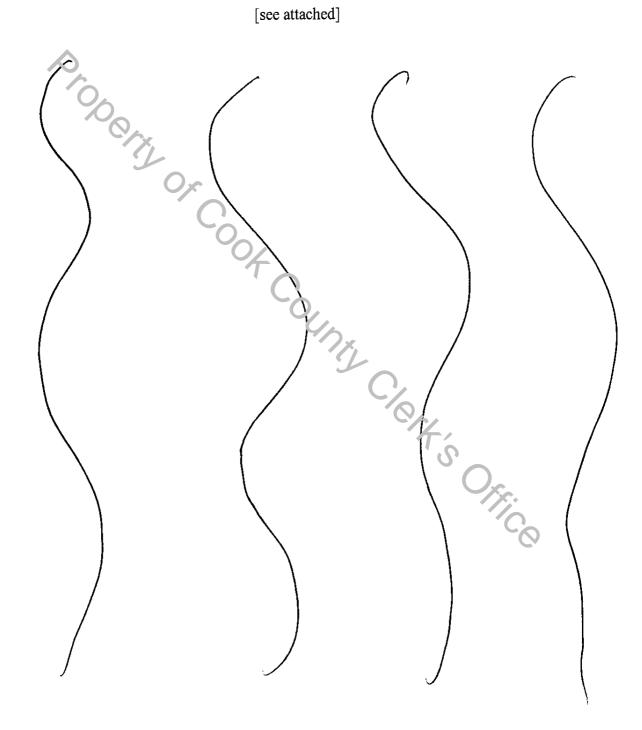
