### **SUBORDINATION AGREEMENT**

This Agreement, made and entered into as of this 23rd day of May, 2005, by and between ARCHER BANK ("Lenger") and ARCHER BANK ("Mortgagee").

### **RECITALS**

WHEREAS, Mortgagee, is the holder of three separate Promissory Notes in the aggregate principal balance of \$2,177,480 which are secured by a Junior Mortgage dated May 3, 2005 made by 4938 SOUTH KEDZIE LLC, an Illinois limited liability company(the "Mortgagor") to Mortgagee, upon the real estate located in the County of Cook, State of Illinois and legally described as follows:

BEGINNING AT THE INTERSECTION OF THE SOUTH LINE OF ELOCK 17 WITH THE WEST LINE OF THE EAST 33.00 FEET OF THE NORTHEAST 1/4 OF SECTION 11 AFORESAID; THENCE WEST ALONG THE SOUTH LINE OF BLOCKS 17 AND 18 AS EXTENDED TO A POINT ON A LINE 45.00 FEET WEST OF AND PARALLEL TO THE EAST LINE OF SPAULDING AVENUE; THENCE NORTH ALONG SAID PARALLEL LINE 355.00 FEET; THENCE NORTHEASTERLY TO A POINT ON THE AFOREMENTIONED WEST LINE OF THE EAST 33.00 FEET OF THE NORTHEAST 1/4 OF SECTION 11 WHICH IS 525.00 FEET NORTH OF THE POINT OF BEGINNING; THENCE SOUTH ALONG SAID WEST LINE OF THE EAST 33.00 FEET, 525.00 FEET TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS.
