### 4. ADJUSTABLE INTEREST RATE AND MONTHLY PAYMENT CHANGES

(A) Change Dates

The initial fixed interest rate I will pay will change to an adjustable interest rate on the first day of June, 2010 , and the adjustable interest rate I will pay may change on that day every 12th month thereafter. The date on which my initial fixed interest rate changes to an adjustable interest rate, and each date on which my adjustable interest rate could change, is called a "Change Date."

#### (B) The Index

Beginning with the first Change Date, my adjustable interest rate will be based on an Index. The "Index" is the average of interbank offered rates for one-year U.S. dollar-denominated deposits in the London market ("LIBOR"), as published in <a href="The Wall-Street Joy.n.al">The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."</a>

If the Index is no longer available, the Note Holder will choose a new index that is based upon comparable information. The Note Holder will give me notice of this choice.

#### (C) Calculation of Changes

Before each Charge Date, the Note Holder will calculate my new interest rate by adding TWO AND ONE-CHARTER percentage points

( 2.250 %) to the Current Index. The Note Holder will then round the result addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal the. THIS CONSTRUCTION LOAN RIDER is made effective as of this 20th day of May , 2005 , and is incorporated into and is deemed to amend and supplement the Mortgage (the "Mortgage") of the same date given by the undersigned (the "Borrower") to secure the Borrower's note of the same date (the "Note") to

In addition to the covenants and agreements made in the Mortgage, the Borrower and the Lender further covenant and agree as follows:

It is understood and agreed, however, that with respect to subsequent purchasers and mortgagees without actual notice, none of the advances or indebtedness arising or accruing under the Loan Agreement shall result in an increase of the indebtedness secured and to be secured hereby over the face amount of the Note beyond 100% of such face amount. In determining the amount of such increase there shall be excluded from any computation all indebtedness which would constitute secured indebtedness under the terms of the Mortgage had this Section been omitted herefrom.

- C. FUTURE ADVANCES.
