This permit is being issued with your agreement to the following terms. Sign below to indicate your assent to these terms. You have informed the Village of Glenview Engineering Department that you are installing a fence at the following location:

LOT 3 IN NORMA ESTATES, A SUBDIVISION OF PART OF LOT 6 IN COUNTY CLERK'S DIVISION IN SECTIONS 25, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN AND DESCRIBED AS FOLLOWS: BEGINNING AT THE SE CORNER OF LOT, THENCE NORTH ALONG THE EAST LINE THEREOF 658.26 FT. TO THE NORTH LINE OF THE SOUTH 5 ACRES OF LOT 6, THENCE WEST ALONG THE NORTH LINE OF SAID SOUTH 5 ACRES 330.87 FT. TO THE WEST LINE OF SAID LOT 6, THENCE SOUTH ALONG SAID WEST LINE 658.26 FT. TO THE SW CORNER OF SAID LOT 6, THENCE EAST ALONG THE SOUTH LINE OF LOT 6 330.57 FT. TO THE POINT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS.

You have also indicated that the fence will be placed in a Public Utility Easement. **At no time shall the posts of the proposed fence be closer than five feet (5') horizontally to the outside edge of any Village pipe in the easement, nor shall the fence itself restrict in any way the natural flow of drainage through the easement or access to any drainage structure or utility pedestal in the easement. Please be advised that the Village of Glenview **will not be responsible** for the replacement of or any damages to, the fence in the easement, for any maintenance or installation work required. The above information is also valid for any future owners of the above said property.
