- C. Defendant Kevin J. Rocio committed fraud and defalcation against the Plaintiffs while acting in a fiduciary capacity, and he thus breached his fiduciary duties to the Plaintiffs, as alleged in Count III of the Complaint in this action.
- D. Defendant Kevin J. Rocio obtained money and property of the Plaintiffs through the use of written and oral false pretenses, false representations and actual fraud.

### IT IS HELFBY ORDERED AND ADJUDGED BY THE COURT:

- A. Final judgment is hereby rendered in favor of the Plaintiffs and against Defendant for the sum of \$317,615.00, consisting of \$76,611.86 of actual damages, \$241,003.14 of "benefit of the bargain" or punitive damages, and \$0.00 of pre-judgment interest.
- B. A memorandum of this final judgment may be recorded in the Public Office.
- C. The Court reserves jurisdiction to entorce the terms of this judgment.
