The interest of each and every beneficiary hereunder and of all persons claiming under them or any of them shall be only in the earnings, avails and proceeds arising from the sale or other disposition of the premises, and that interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to the premises as such, out only an interest in the earnings, avails and proceeds thereof as aforesaid.

Anything herein to the contrary notwith standing, any successor or successors in trust under the Declaration of Trust shall upon acceptance of the trusteeship become fitally vested with all the title, estate, properties, rights, powers, authorities, trusts, duties and obligations of the trustee thereunder.
