- 3 a) That on December 20, 2004, said contractor made a subcontract with the claimant to:

Provide all labor, material and equipment for all Electrical work as per blueprints for 166 rooms; change all switches and receptacles; replace all fixtures in corridors; install new owners supplies for the specified sum of 182,135.00

That the special instance and request of said contractor the Claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$30,295.97 and completed same on March 25, 2005.

b) That on January 31, 2005, said contractor made a subsequent subcontract with the Claimant to:

remove old coax cables and install new ethernet cabling system for the specified sum of 87,600.00 and that the Claimant substantially completed all work thereunder on March 25, 2005.
