THIS INDENTURE WITNESSETH, That the Grantor(s), Stephen W. Zieler and Janene G. Zieler, Married of 15051 Highland Avenue in Orland Park, Illinois 60462 in the County of Cook and in consideration of Ten -----(\$10.00)----- Dollars, and other good and valuable considerations in hand, paid, Convey(s) and Warrant(s) unto the **PALOS BANK AND TRUST COMPANY**, an Illinois Banking Corporation of the United States of America, as Trustee under the provisions of a Trust Agreement dated the 24th day of June, 2005 and known as Trust Number 1-6530 the following described real estate in the County of Cook in the State of Illinois, to wit:

All persons and corporations whomsoever and whatsoever shall be charged with notice of this condition from the date of the filing for record of this Deed.

Any the said Grantor(s) hereby expressly waive(s) and release(s) any and all right or benefit under and by virtue of any and all statutes of the State of Illinois providing for the exemption of homesteads from sale on execution or otherwise.

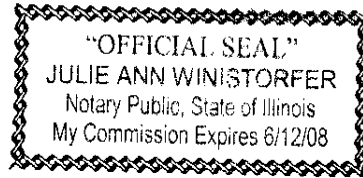

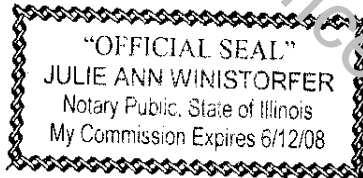
