This Agreement made the _ , 20 05 , by and between the United States of America, Secretary ___ day of ___ June of Housing and Urban Development (he reinafter called "HUD") and __ Holiness Homes of Vision, Inc. a private nonprofit corporation, organiz id and existing under and by virtue of the laws of the State of ______ (hereinafter called the "Owner"), provides as follows: Whereas, the Owner and HUD have entered into a Capital Advance Agreement to assist in financing a rental housing project to house elderly persons or persons with disabilities, (hereinafter called 'posons"), in accordance with Section 202 of the Housing Act of 1959 or Section 811 of the National Affordable Housing Act, and the applicable regulations: Whereas, HUD through the Capital Advance Agreement has provided funding for the Project identified as project number , financed with a Note and Mortgage (Deed of Trust), dated 1, 2005 and covering real property as described in Exhibit "A" attached hereto, which Mortgage was recorded in the Recorder's Office of Cook County on 6/30/05, as Instrument 05.18.10.30.7.5, Book , Page ; Whereas, The Project is subject to a Regulatory Agreement, dated <u>June 1,005</u> and recorded on <u>6/30/05</u> in the Recorder's Office of <u>Cook</u> County as document number <u>05/810.07.11</u>, Book ______, Page _____; Whereas, pursuant to section 202 of the Housing Act of 1959 (elderly projects) or section 511 of the National Affordable Housing Act (disabled projects) and the corresponding regulations, in exchange for HUD's agreement to provide or pival advance financing and project rental assistance payments, the Owner has agreed to continue to operate the Project only as rental housing for ve y-lov income elderly or disabled persons for not less than 40 years from ____ June 1, 2005

Now Therefore, in consideration of the mutual promises set forth herein and of other valuable consideration, are parties hereby agree as follows:

, unless otherwise approved by HUD;

- 1. Definitions. All terms used in this Agreement have the same meaning as set forth in the definitions in 24 CFR Part 889 or 890.
- 2. Term. This Agreement shall remain in effect for not less than 40 years from _ July 1, 2006 otherwise approved by HUD.
- 3. Use Restriction. The Project shall be used solely as rental housing for very-low income elderly or disabled persons.
- 4. Transfer. HUD has been granted and is possessed of an interest in the above described Project such that the Owner shall remain seized of the title to said property andrefrain from transferring, conveying, assigning, leasing, mortgaging, pledging, or otherwise encumbering or permitting or suffering any transfer, conveyance, assignment, lease, mortgage, pledge or other encumbrance of said property or any part thereof without the release of said covenants by HUD. The Owner has constituted HUD as its attorney-in-fact to transfer the project to another private nonprofit corporation in the event of default under the Capital Advance Agreement or the Regulatory Agreement. The Owner may transfer the Project during the term of this Agreement only with the prior written approval of HUD, and any such grantee shall assume the obligations under this Agreement as a condition of any transfer. In any event, this Agreement shall be binding upon the Owner's successors and assigns.
- 5. Release. The endorsement by a only authorized officer of HUD (1) upon any conveyance or transfer made by the Owner of any real or personal property which is determined to the excess to the needs of the Project, or (2) upon any instrument of conveyance or dedication of property, or any interest therein, for use as streets, alleys, or other public rights-of-way, or for the establishment, operation and maintenance of public utilities, or (3) upon any instrume $\mathfrak u$ "ansferring or conveying an interest therein, or (4) upon any instrument of release made by the Owner of the Project shall be effective to release such property from the restrictive covenants hereby created.
- 6. Enforcement. In the event of a breach or threatened breach of any of the provisions of this Agreement, any eligible tenant or applicant for occupancy, or the Secretary or his or her successors or delegates, may institute proper legal action to enforce performance of such provisions, to enjoin any acts in violation of such provisions, to recover whatever damages can be proven, and/or to obtain whatever other relief may be appropriate.
- 7. Severability. The invalidity, in whole or in part, of any of the provisions set forth above shall not affect or invalidate any remaining provisions.
