THIS INDENTURE made this 29th Day of June, 2005, between 918 West Ainslie, LLC, an Illinois limited liability company, with its principal place of business located at 425 West North Avenue, Chicago, Illinois 60610, created and existing under and by virtue of the laws of the State of Illinois and duly authorized to transact business in the State of Illinois, as Grantor and Enez B. Vejseli, An Unmarried Individual, Grantee.

WITNESSETH, the Grantor, in consideration of the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration in hand paid, the receipt of which is hereby acknowledged, in these presents does REMISE, RELEASE, ALIEN and CONVEY unto the Grantee, and to his heirs and assigns, FOREVER, all of the following describe real estate, situated in the County of Cook, State of Illinois, known and described as follows, to wit:

See Exhibit "A" attached hereto and made a part hereof

Together with all and singular the hereditament and appurtenances thereunto belonging, or in anywise appertaining and the reversion and reversions, remainder and remainders, rents, issue and profits thereof and all the estate, right, title, interest, claim or demand whatsoever, unto the Grantee, either in law or in equity, of, in and to the above described premises, with the hereditament and appurtenances: TO HAVE AND TO HOLD the said premises as above described, with the appurtenances, unto the Grantee, his heirs and assigns forever.

Grantor also hereby grants to Grantee, ^{his} her heirs and assigns, all rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said real estate set forth in that certain Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Condominium Association made the 18th day of May, 2005 and recorded on May 24, 2005 in the Office of Recorder of Deeds of Cook County, Illinois, as Document No. 0514403088 (the "Declaration"), and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining real estate described therein. This Deed is subject to all rights, easements, covenants, restrictions and reservations contained in said Declaration the same as though the provision of said Declaration were recited and stipulated at length herein. Grantor further reserves to itself and its successors and assigns, and Grantee hereby grants to Grantor and its successors and assigns, the right to remedy as provided in the Purchase Agreement dated April 4, 2005 between 918 West Ainslie, LLC, an Illinois limited liability company and Enez B. Vejseli for the purchase of the real estate (the "Purchase Agreement") the terms of which are set forth in Exhibit A, attached hereto and made a part hereof. The foregoing right of remedy herein reserved by Grantor and granted by Grantee pursuant to the Purchase Agreement is hereby subordinated to the rights of the holder of any mortgage or trust deed hereafter placed upon the real estate described therein.

3. The Condominium Property Act of the State of Illinois and the Municipal Code of the City of Chicago, Section 13-72 *et seq.*, including all amendments thereto,
4. The Declaration, including all amendments and exhibits attached thereto;
5. Public, private and utility easements recorded at any time prior to closing;
6. Covenants, conditions, agreements, building lines and restrictions of record;
7. Applicable building and zoning laws, statutes, ordinances and restrictions;
8. Roads and highways, if any;
9. Leases and licenses affecting Common Elements and/or the common property;
10. The Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Condominium Association of 918 West Ainslie Condominium Association;
11. Acts done or suffered by the Grantee or anyone claiming by, through or under the Grantee and
12. Grantee's mortgagee.

TO HAVE AND TO HOLD the same unto said Grantee, and to the proper use, benefit and behalf, forever of said Grantee.
