MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated June 13, 2005, is made and executed between Sadie Elders and Eddie Elders, her husband as joint tenants with right of survivorship, whose address is 247 South Ellis, Glenwood, IL 60425 (referred to below as "Grantor") and Heritage Community Bank, whose address is 18301 South Halsted Street, Glenwood, IL 60425 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated September 29, 1999 (the "Mortgage") which has been recorded in Cook County, State of Illinois, as follows:

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

Adjust the monthly payment due date from the 29th of the month to the 5th of the month for the remaining term of the note; Adjust the monthly principal and interest payment from \$1,543.03 to \$1,543.40 beginning 7-5-2005; Adjust the maturity date to October 5, 2009.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in

It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorser to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

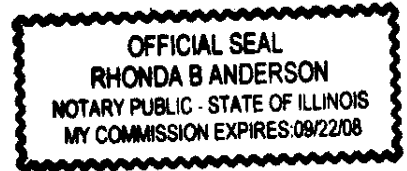

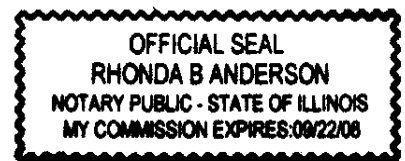
