CRDER

This matter coming before the Court upon the Amended Complaint of the Chicago Title and Trust Company as Trustee under Trust Number Trust Number 1097368 (the "Trust") and ITS BENEFICIARY to quiet title for the property described therein, commonly know as 1329 West 99th St. Chicago, Illinois (the "Property"); the Amended Complaint having been filed on June 10, 2005, and the Trust appearing by Greene and Letts, its attorneys, and Defendants not appearing.

The Court finds that Defendants to this proceeding have been served by process as provided by statute, and that the Court has jurisdiction of the subject matter of this proceeding and of all parties thereto. The Court further finds that Patricia Sharp a/k/a Patricia Metzler was found to be in default on May 19, 2004, and does hereby find that The Estate of Annie Assam and Unknown owners have been served with process by publication and have failed to appear in this matter.
