FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSKIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE ARMITAGE VILLAGE CONDOMINIUM ASSOCIATION

THIS FIRST AMENDMENT to Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and Sy laws for Armitage Village Condominium Association is made as of the 28th day of June, 2005 (hereinafter referred to as the "Third Amendment") by First Midwest Bank, as Trustee under Trust Agreement dated April 21, 2003 and known as Trust Number 6936, (hereinafter referred to as the "Developer") and Bette M. 1. <u>Recitals and Defined Terms</u>. The Recitals set forth above are hereby incorporated as though fully set forth herein. Capitalized terms used in this First Amendment which are not otherwise defined herein shall have the same meanings ascribed to such terms in the Declaration.

2. Amendments.

- A. The Survey of Units attached as <u>Exhibit "A"</u> of the Declaration is hereby amended by deleting <u>Exhibit "A"</u> of the Declaration and replacing said Survey with <u>Exhibit "A-1"</u> attached hereto. Armitage Village Condominium shall hereinafter consist of fifteen (15) residential units and four (4) parking units.
- B. The Percentage of Ownership Interest in the Common Elements attached as Exhibit B of the Declaration is hereby amended by deleting Exhibit "B" and replacing said Percentage of Ownership Interest with Exhibit "B-1" attached hereto
- 3. <u>Inconsistencies</u>. Any inconsistencies between the Declaration and the First Amendment shall be resolved in favor of the First Amendment.
- 4. Other Terms in Effect. Except as set forth herein, all other terms of the Declaration and First Amendment are hereby ratified, approved and confirmed.

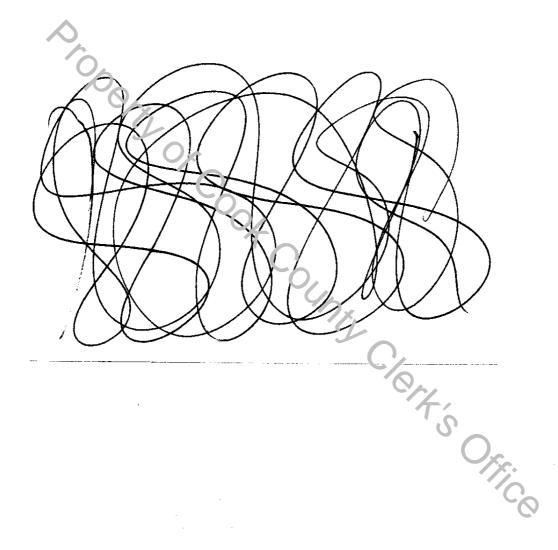
