MEMORANDUM OF ARTICLES OF AGREEMENT FOR DEED

THIS MEMORANDUM OF PURCHASE AND SALE AGREEMENT ("Memorandum") is entered into as of this 28th day of June, 2005, by and between THE SISTERS OF ST. JOSEPH OF THE THIRD ORDER OF ST. FRANCIS, INC., an Indiana corporation ("Seller"), and THE BOAKD OF EDUCATION OF THE CITY OF CHICAGO, a body politic and corporate ("Purchaser").

RECITALS:

- A. Seller and Purchaser have entered into that certain Articles of Agreement for Deed dated as of June 28, 2005 (as same may be amended and assigned from time to time, the "Contract") respecting the sale/purchase of the land legally described on Exhibit A attached hereto (together with certain personal property enumerated in said Contract) and commonly known as 4034 West 56th Street, Chicago, Illinois (collectively, the "Property"); and
- B. Seller and Purchaser desire to enter into this Memora cum for purposes of providing third parties with notice that Purchaser has a contractual right to coquire the Property pursuant to the terms and provisions of the Contract.

NOW THEREFORE, for good and valuable consideration, the receipt and cufficiency of which is hereby acknowledged by the parties, Seller and Purchaser hereby agree as follows:

- 1. <u>Recitals; Definitions</u>. The foregoing recitals are hereby incorporated into this Memorandum by this reference as if set forth at length herein. Capitalized terms used herein which are not otherwise defined herein, shall have the respective meanings ascribed to them in the Contract.
- 2. <u>Agreement to Sell and Purchase</u>. Pursuant to the Contract and this Memorandum, Seller agrees to sell and Purchaser agrees to purchase, the Property upon and subject to the terms and provisions of the Contract.

- 3. <u>Contract Controls Memorandum</u>. This Memorandum is only intended to provide notice of the existence of the Contract and Purchaser's interest as a contract purchaser in the Property, and shall not be deemed to amend or modify any of the terms or provisions of the Contract. The rights and obligations of the parties hereto shall be construed solely by reference to the terms and provisions of the Contract, and in the event of any conflict between the provisions of the Contract and those of this Memorandum, the provisions of the Contract shall control.
- 4. <u>Successors and Assigns</u>. This Memorandum shall inure to the benefit of, and be binding upon Seller and Purchaser and their respective successors and assigns.
- 5. <u>Counterparts</u>. This Memorandum may be executed in counterparts which, when integrated, shall constitute one original of this Memorandum.
