1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. residence for at least one year after the date of occupancy, unless Lender otherwise agrees in writing, which consent shall not be unreasonably withheld, or unless extenuating circumstances exist which are beyond Borrower's control.

7. Preservation, Maintenance and Protection of the Property; Inspections. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate or commit waste on the Property. Whether or not Borrower is residing in the Property, Borrower shall maintain the Property in order to prevent the Property from deteriorating or decreasing in value due to its condition. shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. Property; and (ii) Borrower's obligation under Section 5 to maintain property insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owners Association policy.

What Lender requires as a condition of this waiver can change during the term of the loan.

Borrower shall give Lender prompt notice of any lapse in required property insurance coverage provided by the master or blanket policy.

#### (C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding **Two and 500/1000ths** percentage points (2.500 %) to the Current Index. 
