SEVENTH AMENDED AND RESTATED DECLARATION OF RESTRICTIVE COVENANTS FOR OLD TOWN VILLAGE WEST

THIS SEVENTH AMENDMENT TO AMENDED AND RESTATED DECLARATION OF RESTRICTIVE COVENANTS FOR OLD TOWN VILLAGE WEST ("SEVENTH WEST AMENDMENT") is entered into and effective as of July 15, 2005, by and between the Chicago Housing Authority (the "Authority"), in Illinois municipal corporation, with offices at 626 West Jackson Boulevard, Chicago, Illinois 60601, and Southwest Old Town Development Associates, L.L.C., an Illinois limited liability company (the "Owner"). Capitalized terms not otherwise defined herein shall have the meaning set forth in that certain Declaration of Restrictive Covenants for Old Town Village West dated effective as of November 7, 2003 and recorded in the Recorder's Office of Cook County on November 7, 2003 as document no. 0331132071, and as further amended by the First West Amendment dated effective December 3, 2003 and recorded in the Recorder's Office of Cook County on December 3, 2003 as document no. 0333739139, and further amended by the Second West Amendia in dated effective February 27, 2004 and recorded in the Recorder's Office of Cook County on February 27, 2004 as document no. 0405844064, further amended by the Third West Amendment dated effective May 26, 2004 and recorded in the Recorder's Office of Cook County on May 26, 2004 as document no. 0414719071, as further amended by the Fourth West Amendment dated effective September 24, 2004 and recorded in the Recorder's Office of Cook County on September 24, 250% as document no. 0426839066, further amended by the Fifth West Amendment dated effective March 16, 2005 and recorded in the Recorder's Office of Cook County on March 21, 2005 as document no. 0508034010 and further amended by the Sixth West Amendment dated effective April 15, 2005 and recorded in the Recorder's Office of Cook County on April 15, 2005 as document no. 0510539059 (as amended hereby, the "West Amended Declaration").

WHEREAS, Authority and Owner have previously executed and recorded the West Amended Declaration, which encumbers certain public housing units (the "CHA Condominium Units") described in Exhibit C thereto with certain low-income public housing requirements and imposes certain other obligations upon the Owner; and simultaneously releases certain non-public housing condominium units (the "Private Units") described in Exhibit D thereto; and

WHEREAS, the Owner has converted a portion of the Development, as defined in the West Amended Declaration, to a condominium form of ownership which includes certain CHA Condominium Units together with their undivided interest in the Development and all common elements and limited common elements; and

Amended Declaration to reflect the current status of the Private Units, the CHA Condominium Units, and all coner real, personal and intangible property owned by the Owner that is now subject to the West Amended Declaration and encumbered by the obligations set forth in the West Amended Declaration;

NOW, THEREFORE, i. consideration of the mutual promises and covenants hereinafter set forth, and of other valuable consideration, the Owner and the Authority each agree as follows:

SECTION 1. AMENDMENT OF EXHIBIT C. Exhibit C to the West Amended Declaration is hereby amended and restated to read as set forth in Exhibit C to this Seventh West Amendment.

SECTION 2. AMENDMENT OF EXHIBIT D Exhibit D to the Amended Declaration is hereby amended and restated to read as set forth in Exhibit D to this Seventh West Amendment.

SECTION 3. FULL FORCE AND EFFECT. Except as arresided by this Seventh West Amendment to the West Amended Declaration, the terms of the West Amended Declaration remain in full force and effect, and are incorporated herein by reference as though fully set forth herein.

SECTION 4. COUNTERPARTS. This Seventh West Amendment to the West Amended Declaration may be executed in multiple counterparts, each of which shall be an original, but all of which together shall constitute but one in the same agreement.
