AGREED ORDER OF JUDGMENT AND ENFORCEMENT WITH SETTLEMENT

This matter coming on to be heard by the Court, the Court having heard evidence and testimony and having made a finding of **Full Compliance / Substantial Compliance** subject to reinspection of the violations listed in the Plaintiff's complaint;

IT IS HEREBY ORDERED THAT:

1. Judgment in the total amount of \$ 4,000 plus \$60.00 in court costs against defendant(s) Rapallo Salama shall stand as final judgment on Count I. 3. If this case is dismissed subject to reinspection, Defendant(s) must call the assigned City inspector at (312) 746-\_\_\_\_\_ within \_\_\_\_\_ days to arrange for an inspection of the subject premises.

4. This order is final, enforceable, and appealable, the court finding no just cause or reason to delay its enforcement or appeal.
