SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT, made in the City of Chicago, State of Illinois, this 29thday of June, 2005, by JPMorgan Chase Bank, NA, a national banking association organized and existing under and by virtue of the laws of the United States of America, and doing business and having its principal office in the City of Winnetka, County of Cook, and State of Illinois ("Bank").

WITNESSETH

WHEREAS, the Bank is the owner of a mortgage dated August 4, 2004 and recorded August 31,2004 among the land records in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number 0424432028 made by Thomas R. Wegert and Ellen R. Wegert ([collectively,] "Grantor"), to secure an indebtedness of \$ \$00,000.00 ("Mortgage"), and

WHEREAS, Grantor is the owner of that certain parcel of real estate commonly known as 362 Hawthron Lane, Winnetka, IL 60093 and more specifically described as follows:

WHEREAS, Alliance Financial Mortgage, Corp., its successors &/o. assigns ("Mortgagee") has refused to make a loan to Thomas R. Wegert and Ellen R. Wegert ([collectively,]"Borrover") of \$994,000.00 except upon condition that the Mortgage be subordinate to said mortgage lien of Mortgagee.

NOW, THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars in hand paid by each of the parties hereto to the other, and of other good and valuable consideration, the receipt and suff ciency of which are hereby acknowledged and in order to induce Mortgagee to make the loan to Borrower, it is note by mutually agreed, as follows:

- I. That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated 7/6/05 reflecting and securing the loan made by Mortgagee to Borrower, in the amount of \$994,000.00 plus interest as charged according to the terms of the Mortgage note, and to all renewals, extensions or replacements of said mortgage; and
- II. That this Agreement shall be binding upon and shall inure to the benefit of Mortgagee, its successors and assigns.
