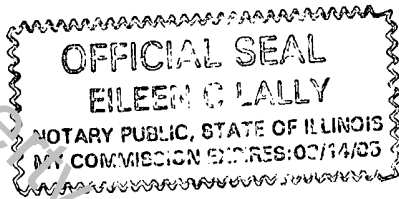

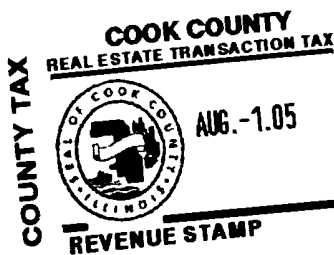

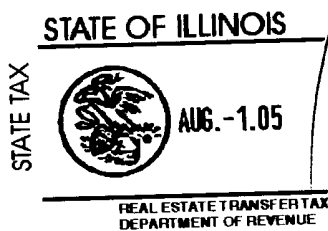

## EXHIBIT A LEGAL DESCRIPTION

PARCEL 1:
