Know all men by these presents that the undersigned, 2472 West Foster, LLC, holder as aforesaid of the title to the property legally described on Exhibit A attached hereto does hereby covenant and agree for itself, its successors and assigns, that the maintenance and repair of the common sewer lines located anywhere on the property from the point of connection to the sewer main in the public street shall be the responsibility of the owners of the four-story, mixed-use building with thirty-six residential condominiums above first floor retail condominiums and parking (the "Condominium Building"), all to be constructed as approved by the City of Chicago, as amended from time to time, and shall not be the responsibility of the City of Chicago. The andersigned further states that this covenant shall run with the land and shall be binding upon an subsequent grantees. This covenant is made to induce the City of Chicago to furnish sewer and water service to the above described premises.

Also, the undersigned does hereby covenant and agree for itself, its successors and assigns, that the maintenance and repair of the water service trunk line located anywhere on the property from the point of connection to the water main in the public street shall be the responsibility of the owner of the Condominium Building and shall not be the responsibility of the City of Chicago.

The undersigned does hereby further covenant and agree for itself, its successors and assigns, that the buffalo boxes (water service shut-off valves) and water meters for the Condominium Building shall be accessible at all times to the City of Chicago.

The City of Chicago Water Department will have the right to come on the private property to shut off water for non-payment.
