- 1. - 7. Mortgager shall pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the option of the Mortgagee, and without pouce to Mortgagors, all unpaid indebtedness secured by this Mortgage shall, notwithstanding anything in the note or in the Mortgage to the contrary, become due and payable (1) immediately in the case of default in making payment of any installment of principal or interest on the note, or (2) when default shall occur and continue for three days in the performance of any other agreement of the Mortgagors herein contained.
