Lender will be named as the loss payee on all such policies pursuant to a standard lender's loss payable clause. - (b) Upon the occurrence of a default as set forth in Section 7(a) above, Lender may institute an action to foreclose this Mortgage under Illinois law. Lender may seek any other remedies available to it under applicable Illinois law.
