MODIFICATION OF MORTGAGE

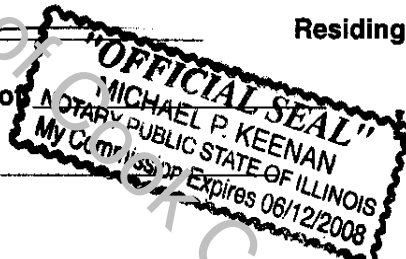
