ILLINOIS STATUTORY SHORT FORM POWER OF ATTORNEY FOR PROPERTY

(NO FICE: THE PURPOSE OF THIS POWER OF ATTORNEY IS TO GIVE THE PERSON YOU DESIGNATE (YOUR "AGENT") BROAD POWERS TO HANDLE YOUR PROPERTY.
