POWER OF ATTORNEY

THE STATE OF ILLINOIS

COUNTY OF COOK

NOW ALL MEN BY THESE PRESENTS, that I/We, **CATHERINE A. HABES**, OF **COOK COUNTY, ILLINOIS**, have made, constituted and appointed, and BY THESE PRESENTS do make, constitute and appoint, **ROBERT HABES** of **KANE County, State of Illinois**, my true and lawful agent and ATTORNEY-in-fact (hereinafter referred to as "attorney") for me and in my name, place and stead to make, execute, acknowledge, amend, modify and deliver in my name such notes, agreements, promises to pay, affidavits, closing statements, contracts, instrument of conveyance, mortgage or lease, and any and all other instruments, agreements and documents as my said attorney may deem appropriate and which are in any way related to any transaction involving the ownership, maintenance, financing, to execute any and all documents relating to the completion of an IRC Section 1031 Deferred Exchange, purchase and/or sale of, or any matter in any way related to, the following described property ("the property"):

This power of attorney shall not terminate on disability of the principal.

The attorney named herein shall not be obligated to furnish bond or other security.

Any authority granted to my attorney herein shall be limited so as to prevent this power of attorney from causing my attorney to be taxed on my income and from causing my estate to be subject to a general power of appointment by my attorney, as that term is defined in Section 2401 of the Internal Revenue Code.

I hereby ratify and confirm all that my attorney, or his successors, shall lawfully do or cause to be done by virtue of this power of attorney and the rights and powers granted herein.

I hereby bind myself to indemnify my attorney herein named and any successor who shall so act against any and all claims, liabilities, demands, losses, damages, actions and causes of action, including expenses, costs and reasonable attorneys' fee which my attorney at any time may sustain or incur in connection with his carrying out the authority granted him in this power of attorney.

This power of attorney and the powers herein granted may be revoked only by (i) my death, or (ii) revocation by an instrument in writing, duly executed and acknowledged by me and filed for record in the office of the County Clerk of the County and State in which the Property is located. It is my intention that any person or any firm, corporation, joint
