AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND BYLAWS, EASEMENTS, RESTRICTIONS AND COVENANTS ESTABLISHING A PLAN FOR CONDOMINIUM OWNERSHIP AT 833-535 W. BELLE PLAINE, CHICAGO, ILLINOIS 60613

(This Amendment does not change percentage ownership interests, or create or delete any Units)

This Amendment to Declaration of Condominium Ownership and Bylaws, Easements, Restrictions and Covenants Establishing a Plan for Condominium Ownership at 833-835 W. Belle Plain, Chicago, Illinois 60613 (the 'Arnendment'), made and entered into this 26th day of July, 2005, by the undersigned constituting all the Members of the Board and at least 75% of the Unit Owners,

#### WITNESSET71:

WHEREAS, by a Declaration of Condominium Ownership and Bylaws, Easements, Restrictions and Covenants Establishing a Plan for Condominium Ownership at 833-835 W. Belle Plain, Chicago, Illinois 60613 recorded in the Office of the Recorder of Cook County, Illinois on February 6, 1996, as Document No. 96-099412 (the "Declaration"), Crescent Condominiums, Inc. submitted certain real estate to the provisions of the Hilpois Condominium Property Act (the "Act"). The legal description of the real estate so submitted is attached hereto as Exhibit A and made a part hereof; and

WHEREAS, Article XX of the Declaration provides for amendments to the Declaration by an instrument in writing signed and acknowledged by all of the Members of the Board, at least 75% of the Unit Owners and the approval of any mortgagees required under the provisions of the Condominium Instruments; and

WHEREAS, the undersigned desire to amend the Declaration in the manner hereinafter set forth; and

WHEREAS, such amendment does not require the approval of any mortgagees.

NOW, THEREFORE, the undersigned do hereby amend the Amended Declaration as follows:

- 1. All capitalized terms contained but not defined herein shall have the meaning as ascribed to such terms in the Declaration.
  - 2. Article XVI, Section 7 of the Declaration is amended to read as follows:

"No animals, reptiles, rabbits, livestock, dogs, fowl, or poultry of any kind shall be raised, bred, or kept in any Unit or in the common Elements, except that cats, birds, or fish may be kept in Units subject to rules and regulations adopted by the Board. Any cat, bird, or fish causing or creating a nuisance or unreasonable disturbance shall be permanently removed from the Property upon three (3) days written notice from the Board."

3. Article YVI, Section 11 of the Declaration is amended to read as follows:

No Units shall be leased. An owner may ask the Board to grant permission for a one-time emergency lease of their unit if necessary. If the one-time emergency request is approved, the lease shall be no shorter than six (6) months and no longer than one (1) year. The request may not be extended. If approved by the Board, such lease must be in writing, and a copy must be delivered to the Association before Unit occupancy. Any failure of the lessee to comply with terms of this Declaration and the Rules and Regulations of the Association shall be a default under the lease. The Board may adopt additional Rules and Regulations applicable to the approved one-time emergency leasing of units as it deems advisable and necessary."

4. Amended as set forth herein, the Declaration remains in full force and effect in accordance with its terms.
