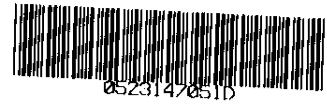

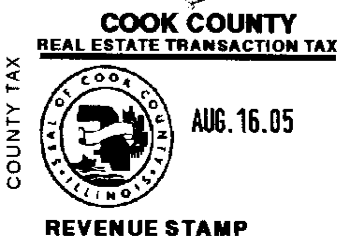
SPECIAL WARRANTY DEED

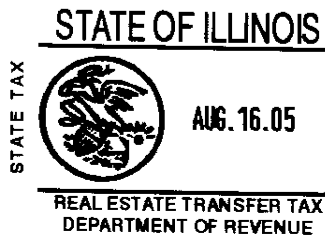

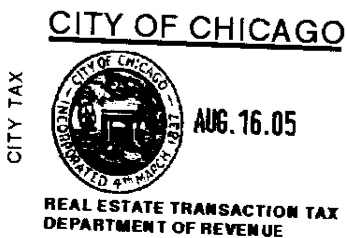
