MEMORANDUM OF TERMINATION OF USE RESTRICTION

This Memorandum of Termination of Us: Restriction ("Memorandum") is executed this April, 2005, by and between Jetco Properties, Inc., De aware corporation ("Jetco"), and 2526 West Cermak LLC, an Illinois limited liability company ("First Party")

WHEREAS, Jetco previously sold to First Party the exproperty located in the County of Cook, State of Illinois, more particularly described in Exhibit "A" attached here to and incorporated herein ("Subject Property"), pursuant to a Special Warranty Deed dated June 14, 2002, and recorded July 2, 2002, as Document Number 0020734386 (the "Deed").

WHEREAS, the Deed provides in part that for a period of ten (10) years from the date of the Deed, no part of the Subject Property shall be used as a supermarket (which shall be defined 2. ar.y store or department containing more than 20,000 square feet of floor area, including aisle space and storage, prime rily devoted to the retail sale of off for off-premises consumption) or for the sale of fresh or frozen meat, fish, poultry or produce for off-premises consumption; or for the sale or offer of sale of any ethical pharmaceutical products requiring the services of a registered pharmacist (collectively the "Restriction").

WHEREAS, Jetco and First Party entered into an Agreement Regarding Use Restriction dated April 11, 2003, and as amended on October 11, 2004, and First Party has exercised its option thereunder to terminate the Restriction prior to its expiration.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars and No Cents (\$10.00) and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Restriction is hereby terminated and shall no longer restrict such uses on the Subject Property or encumber the Subject Property, effective upon the recording of this Memorandum in the Official Records of the County of Cook, State of Illinois.
