WILLIAMSON'S SHERIDAN ROAD SUBDIVISION IN SECTION 21 AND 22, TOWNSHIP 42 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO PLAT OF SAID SUBDIVISION RECORDED APRIL 8, 1920.
