This matter coming on to be heard by the Court, the Court having heard evidence and testimony and having made a finding of Full Compliance / Substantial Compliance subject to reinspection of the violations listed in the Plaintiff's complaint;

IT IS HEREBY ORDERED THAT:

1. Judgment in the total amount of \$ 4000.00 plus \$60.00 in court costs against defendant(s) Fred Davis shall stand as final judgment on Count I. Leave enforcement on said judgment is stayed ~~\_\_\_\_\_ days, or~~ until 8/31/05. Execution is to issue on the judgment thereafter. If payment is mailed it must be postmarked within the aforesaid time limit and mailed to the attention of Tina Zvanja at 30 N. LaSalle, Room 700, Chicago, IL 60602.

3. If this case is dismissed subject to reinspection, Defendant(s) must call the assigned City inspector at (312) 746-\_\_\_\_\_ within \_\_\_\_\_ days to arrange for an inspection of the subject premises.
