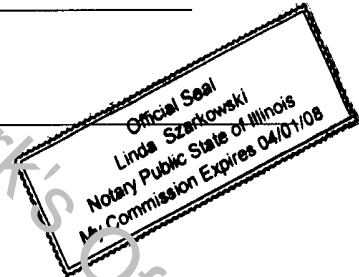

## EXHIBIT B
