Such loss reserve shall be non-refundable, notwithstanding the fact that the Loan is ultimately paid in full, and Lender shall not be required to pay Borrower any interest or earnings on such loss reserve. The interest rate I will pay may change on the first day of SEPTEMBER, 2008, and on that day every sixth month there iter. Each date on which my interest rate could change is called a "Change Date."
