SPECIAL WARRANTY DEED

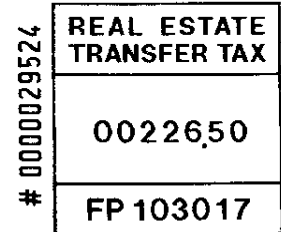
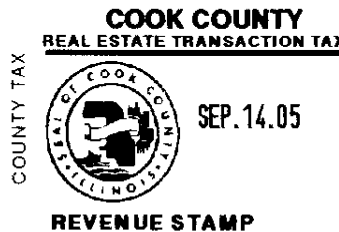
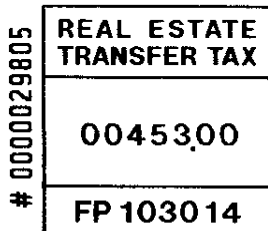
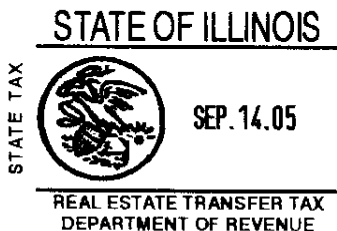
