### ABROGATION AGREEMENT

This Phrogation Agreement is made this 19th day of 1, 2005 by Midwest Real Estate Investment Company Employees' Profit Sharing Plan and Trust ("Midwest") and the Village of Hoffman Estates ("Village").

### WITNESSETH:

WHEREAS, a Plat of Subdivision for the Cancer Treatment Center Subdivision in Hoffman Estates, Illinois ("Plat") was recorded in the Office of the Recorder of Deeds of Cook County, Illinois on March 26, 1997 as Document No. 97211351. A certified copy of the Plat is attached hereto as "Exhibit A."

WHEREAS, Midwest is the owner of the following described, unimproved parcel of real estate in the Cancer lrealment Center Subdivision in Hoffman Estates, Illinois ("Parcel"):

Lot 1 in Cancer Treatment Center Subdivision, being a Subdivision of part of the Vest half of the Northeast 1/4 of Section 7, Township /1 North, Range 10, East of the Third Principal Meridian, in Cook County, Illinois.

WHEREAS, the Plat provides for the reservation and granting of a 10-foot water main easement ("Easement"), beginning at the scuthern border of the Parcel and running northwesterly in a y-shaped formation to the northern border of the Parcel. The Easement is more fully depicted in the attached "Exhibit A."

WHEREAS, the Village has the sole responsibility for installing, removing, and otherwise maintaining water mains which service real estate located within Hoffman Estates, Illinois.

WHEREAS, the Village represents that no water mains have ever been installed in the Easement located on the Parcel as of the date of this instrument.

NOW, THEREFORE, in consideration of mutual covenants and promises expressed herein, and for other good and valuable consideration, the receipt and sufficiency of which are herewith acknowledged, the parties agree as follows:

- 1. <u>PREAMBLE</u>: The recitals set forth in the preamble of this Abrogation Agreement are incorporated herein and made a part hereof by this reference.
- 2. <u>ABROGATION OF EASEMENT</u>: The Plat is modified to abrogate and otherwise vacate the Easement located on the Parcel.
