

SUPPLEMENT NO. 2 TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR LION'S GATE CONDOMINIUM

This Supplemental Condominium Declaration is made by and entered into by DRH Cambridge Homes, Inc., a California corporation ("Declarant").

RECITALS:

Declarant Recorded the Declaration of Condominion Ownership for Lion's Gate Condominium in the Office of the Recorder of Deeds for Cook County, Illinois on July 26, 2005, as Document No. 0520744081 (the "Condominium Declaration"). The Condominium Declaration submitted certain real estate to the provisions of the Condominium Property Act of the State of Illinois (the "Act") and subjected such real estate to the Cordominium Declaration.

In Article Eight of the Condominium Declaration, Declarant reserved the right and power to add portions of the Development Area from time to time to the Condominium Declaration and submit such portions to the provisions of the Act. Declarant exercised the right and power reserved in Article Eight by recording Supplement No. 1 to the Condominium Declaration on August 31, 2005, as Document No. 0524334043.

Declarant once again desires to exercise the right and power reserved in Article Eight of the Condominium Declaration to add and submit certain real estate to the provisions of the Act and the Condominium Declaration.

NOW THEREFORE, Declarant does hereby supplement and amend the Condominium Declaration as follows:

1. Terms. All terms used herein, if not otherwise defined herein, shall have the meanings set forth in the Condominium Declaration.

- 2. Added Condominium Property/Amendment of Exhibit B. The portion of the Development Area which is legally described in the Second Amendment to Exhibit B attached hereto is hereby made subject to the Condominium Declaration as "Added Condominium Property" and is also submitted to the provisions of the Act. Exhibit B to the Condominium Declaration is hereby amended to include the Added Condominium Property which is legally described in the Second Amendment to Exhibit B attached hereto.
- 3. The Added Dwelling Units/Amendment of Exhibit C. Exhibit C to the Condominium Declaration is hereby amended by adding to and making a part of Exhibit C the plats of the Added Condominium Property which are attached hereto. Exhibit C, as hereby amended and supplemented, identifies each Added Dwelling Unit in the Condominium Property and assigns to it an identifying symbol.
- 4. <u>Amendment of Exhibit D</u>. To reflect the addition of the Added Dwelling Units, the list of the Undivided Interests of the Dwelling Units as shown in Exhibit D to the Condominium Declaration is hereby amended to be as set forth in the Second Amended and Restated Exhibit D, which is attached hereto.
- 5. Covenants to Run With I and. The covenants, conditions, restrictions and easements contained in the Condominium Declaration, as amended by this Supplemental Condominium Declaration, shall run with and bind the Condominium Property, including the Added Condominium Property and Added Dwelling Units.
- 6. <u>Continuation</u>. As expressly hereby amended, the Condominium Declaration shall continue in full force and effect in accordance with its terms.


