hereditaments and appurtenances: TO HAVE AND TO HOLD the said premises as above described, with the appurtenances, unto the Grantee, its successors and assigns forever.

Grantor also hereby grants to the Grantee, its successors and assigns, as rights and easements appurtenant to the subject Unit described herein, the rights and easements for the benefit of said Unit set forth in the Declaration of Condominium recorded as Document No. <u>0.519644013</u>; and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining land described therein.

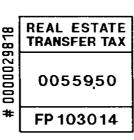

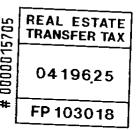
Grantor also hereby releases and waives all rights under and by virtue of the Homestead Exemption Laws of the State of Illinois.

- 6. Acts done or suffered by Grantee or anyone claiming by, through or under Grantee.
- 7. Leases and licenses affecting the Common Elements as defined in the Condominium Declaration.
- 8. Covenants, conditions, agreements, building lines and restrictions of record.
- 9. Easements recorded at any time prior to Closing, including any easements established by or implied from the Condominium Declaration or amendments thereto.
- Liens, encroachments and other matters over which the Greater Illinois Title Company is willing to insure over at Grantor's expense; provided, however, that the title exceptions described in 5, 7, 8, or 9 above shall not prohibit the Grantee's use of the Unit as a single-family residence.
