# Open of Re: Sewer Line Maintenance

This Covenant is made by 13th & state, L.L.C., an Illinois limited liability company (the "Developer").

The Developer is the title holder of the real estate which is legally described in Exhibit A attached hereto (the "Vision on State Property"). The City of Chicago has requested that the Developer make certain covenants which will run with the land concerning the maintenance, repair and replacement of the common sewer lines which (erv) the Vision on State Property. The Developer is hereby willing to do so.

Accordingly, the Developer hereby covenants and agrees for itself, its successors and assigns that the maintenance, repair and replacement of the sewer lines (which will be constructed in accordance with the plans approved by the City of Chicago, as an ended from time to time) which serve the Vision on State Property and which extend from points of connection with the sewer main in the public street to the improvements located on the Vision on State Property shall, at all times, be the obligation of the Developer, its successor scard assigns.
