SUBORDINATION OF MORTGAGE OR TRUST DEED

This Subordination Agreement (the "Agreement") is made and entered into this 16TH day of SEPTEMBER 2005 by and among MidAmerica Bank, fsb., (the "Lender"), MIDAMERICA BANK (the "Subordinating Party") and RAFAEL CHAVEZ, AN UNMARRIED

PERSON AND DONITA ONTIVEROS, AT UNMARRIED PERSON

(hereinafter collectively referred to as the "Borrowers").
