EXHIBIT A TO UCC FINANCING STATEMENT

(iii) others possess, use or have authority to possess or use property (whether targible or intangible) of the Grantor, and all recorded data of any kind or nature, regardless of the medium of recording, including, without limitation, all software, writings, plans, specifications and schematics.
