- (i) acts done or suffered by Grantee.

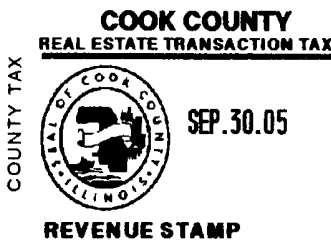

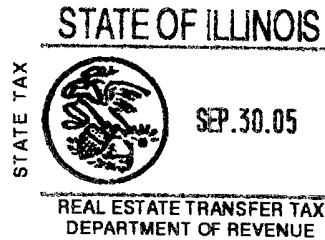

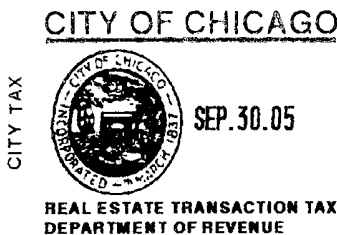
