IT IS FURTHER ORDERED that the above-entitled matter be and the same is hereby dismissed.

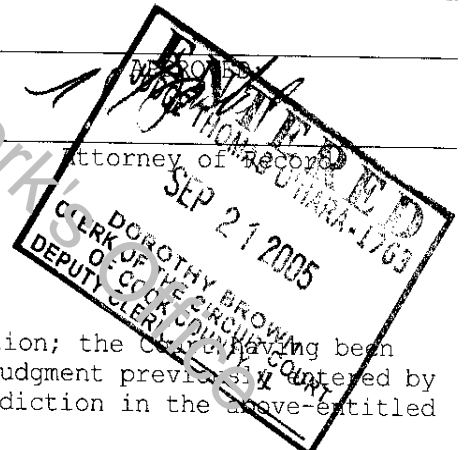
