## **SECTION FOUR**


All ordinances or parts of ordinances in conflict herewith are hereby repealed.

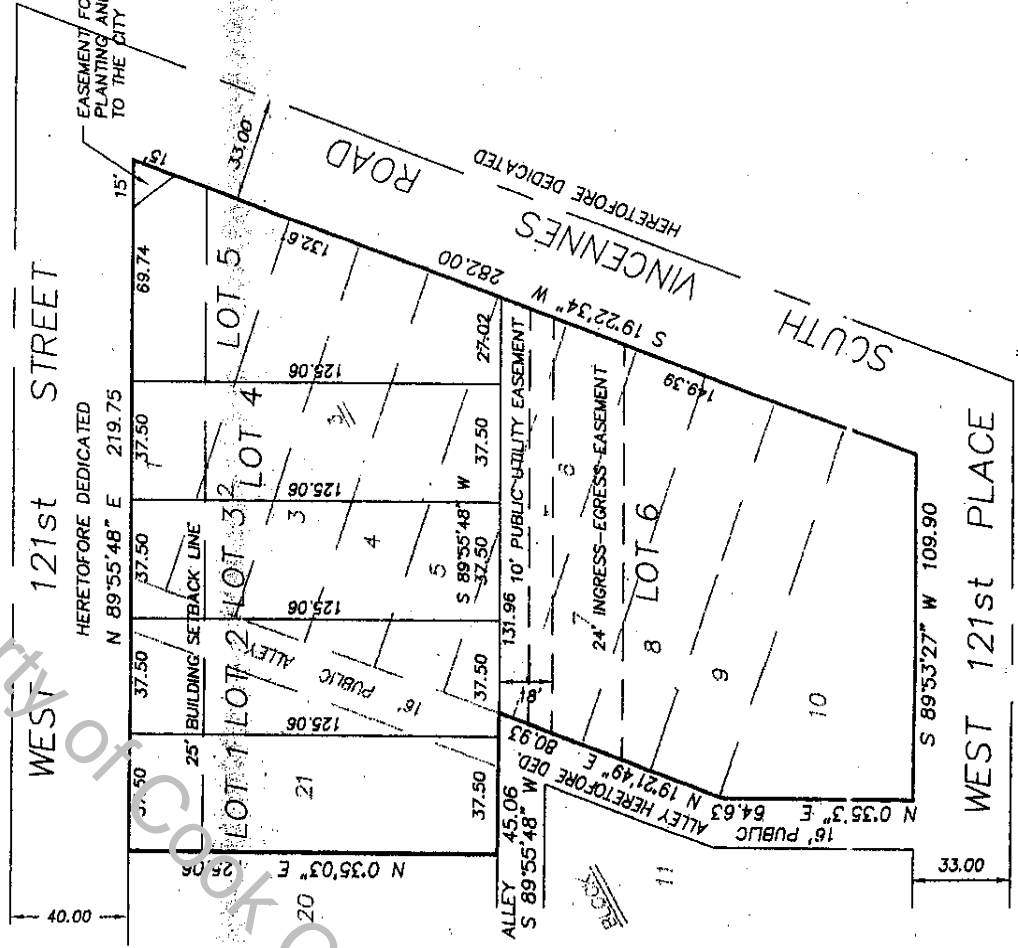
