### 3. Representations of Borrower. Borrower represents that:

  - (b) The Property is not used for any agricultural or farming purposes.

### 4. Promises of Borrower. Borrower promises:

Lender will be named as the loss payee on all such policies pursuant to a standard lender's loss payable clause. The amount collected under any insurance policy may be applied upon any indebtedness hereby secured in the same manner as payments under the Note or, at Lender's sole option, released to Borrower. In the event of foreclosure or sale of the Property all rights of the Borrower in insurance policies then in force shall pass to the purchaser.

- 5. Sale Transfer, or Further Encumbrance of Property. Borrower shall pay when due all assessments imposed by the Owners' Association.
