4. The assignment of P-4 as on LCE to Unit 2S is hereby deleted and said P-4 is herewith assigned as a Limited Common Element to Unit 1S.
5. The assignment of P-5 as on LCE to Unit 2N is hereby deleted and said P-5 is herewith assigned as a Limited Common Element to Unit GS.


